ESTABLISHING A CONTROLLED ARCHERY DEER HUNT**


WHEREAS, the City Council recognizes that the over population of deer is causing financial and safety problems for the citizens of Cherokee Village; and


WHEREAS, on February 6, 2008 the City Council met in a work session to discuss the subject of a controlled archery deer hunt and what actions to take;
