

ORDINANCE # 2001- 05

**AN ORDINANCE TO REESTABLISH WARD BOUNDARIES, BASED
ON THE 2000 CENSUS, WITHIN THE CITY OF CHEROKEE VILLAGE
WHICH IS LOCATED IN SHARP AND FULTON COUNTIES, ARKANSAS**

WHEREAS, The City Council of the City of Cherokee Village and its 2000 Census Committee have made a comprehensive study and review of the 2000 Census Block Maps and 2000 Census Block Tabulations for those portions of Fulton County and Sharp County, Arkansas, known as the City of Cherokee Village, and;

WHEREAS, it is the opinion of the City Council of Cherokee Village that the revised Ward Boundaries, as hereafter set out, equalize (within +/- 5%), the population within the various wards.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHEROKEE VILLAGE, ARKANSAS AS FOLLOWS:

1. Map of City - The boundaries and limits of the wards within the City of Cherokee Village shall be as set forth and described on the "official map of the city", on file in the office of the City Clerk/Treasurer.

2. Ward Boundaries - The following WARDS within the City of Cherokee Village and their descriptions are hereby established: (Ward Boundaries Hereto Attached as Exhibit "A")

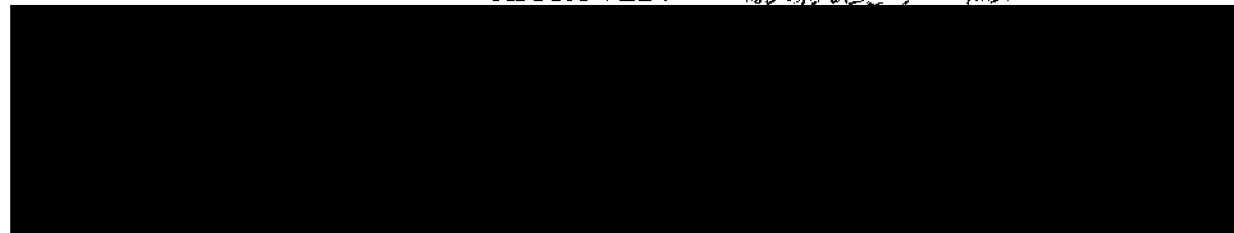


EXHIBIT "A"

WARD 1

All those lands lying within the incorporated city limits of the City of Cherokee Village lying east of Arkansas State Hwy. 289, and north of a line described as follows: beginning at its intersection of the centerline of Arkansas State Hwy. 289 and Arkansas State Hwy. 175; thence, easterly along the centerline of Arkansas State Hwy. 175 to its intersection with the centerline of Santee Drive; thence, northerly along the centerline of Santee Drive to its intersection with the centerline of Cherokee Road; thence, northerly along the centerline of Cherokee Rd, swinging westerly over the South Fork of the Spring River to a point midway between Flathead Drive and Nebo Drive; thence, due north to the northern boundary of the incorporated city limits of Cherokee Village.

WARD 2

All those lands lying within the incorporated city limits of Cherokee Village lying east and west of Arkansas State Hwy. 289, and south and west of a line described as follows: beginning at its intersection with the centerline of Arkansas State Hwy. 289 and Arkansas State Hwy. 175; thence, easterly along the centerline of Arkansas State Hwy. 175 to its intersection with the centerline of Okmulgee Drive; thence, southerly along the centerline of Okmulgee Drive to a point midway between its intersections of Wyandotte Drive and Wewaka Drive; thence, due south to the west of, and parallel to, Wewaka Circle to its intersection with the centerline of Waketa Drive; thence, easterly and southerly along the centerline of Waketa Drive to its intersection at the centerline of Enid Drive; thence, southerly along the centerline of Enid Drive to its intersection with the centerline of Allegheny Drive; thence, westerly along the centerline of Allegheny Drive to its intersection with the centerline of Saskatchewan Drive; thence, southerly along the centerline of Saskatchewan Drive, swinging westerly to its intersection with the centerline of Allegheny Drive; thence, westerly along the centerline of Allegheny Drive to its intersection with the centerline of Pottawattamie Drive; thence, southerly along the centerline of Pottawattamie Drive to its intersection with the centerline of Tekawitha Drive; thence, southerly along the centerline of Tekawitha Drive to the hiway right-of-way for Arkansas State Hwy. 62/412, which is the southern boundary of the incorporated city limits of the City of Cherokee Village.

WARD 3

All those lands lying within the incorporated city limits of the City of Cherokee Village confined within the following described line: beginning at its intersection of the centerline of Tekawitha Drive and the hiway right-of-way for Arkansas State Hwy. 62/412, which is the southern boundary of the incorporated city limits of the City of Cherokee Village; thence, northerly along the centerline of Tekawitha Drive to its intersection with Pottawattamie Drive; thence, northerly along the centerline of Pottawattamie Drive to its intersection with the centerline of Allegheny

Drive; thence, easterly along the centerline of Allegheny Drive to its intersection with the centerline of Saskatchewan Drive; thence, easterly along the centerline of Saskatchewan Drive, swinging northerly to its intersection with the centerline of Allegheny Drive; thence, easterly along the centerline of Allegheny Drive to its intersection with the centerline of Enid Drive; thence, northerly along the centerline of Enid Drive to its intersection with the centerline of Waketa Drive; thence, northerly along the centerline of East Waketa Drive to a point east of Merrimac Drive; thence, from the centerline of East Waketa Drive, due north, passing to the west of, and parallel to, Wewaka Circle, to an intersection with the centerline of Okmulgee Drive; thence, northerly along the centerline of Okmulgee Drive to its intersection with the centerline of Arkansas State Hwy. 175; thence, easterly along the centerline of Arkansas State Hwy. 175 to its intersection with the centerline of Iroquois Drive; thence, southerly along the centerline of Iroquois Drive to its intersection with the centerline of West Lake Estates Circle; thence, southerly along the centerline of West Lake Estates Circle to its intersection with the centerline of West Lakeshore Drive; thence, southerly along the centerline of West Lakeshore Drive to its southern-most point; thence, following the incorporated city limits of the City of Cherokee Village in a westerly direction, then in a southerly direction until the incorporated city limits of the City of Cherokee Village intersects with the centerline of Rebel Drive; thence, westerly along the centerline of Rebel Drive to a point the incorporated city limits of the City of Cherokee Village exits the centerline of Rebel Drive in a westerly direction, followed by an angular turn to a southerly direction, to once again intersect with the centerline of Rebel Drive; thence, westerly along the centerline of Rebel Drive, and again leaving the centerline of Rebel Drive in a northwesterly direction to intersect with the centerline of Iroquois Drive; thence, westerly along the centerline of Iroquois Drive to a point east of Palace Drive; thence, departing the centerline of Iroquois Drive in a southerly direction to intersect with the Arkansas State Hwy. 62/412 right-of-way; thence, westerly along the southern incorporated city limits of the City of Cherokee Village to the point of beginning.

WARD 4

All those lands lying within the incorporated city limits of the City of Cherokee Village confined to areas that lie to the north and east of the following described line: beginning at a location south of the southern intersection of Hiawatha Drive and Algonquin Circle (the incorporated city limits of the City of Cherokee Village); thence, in a westerly direction and south of the southern leg of Algonquin Circle to a point that intersects with the southern-most point of West Lakeshore Drive; thence, northerly along the centerline of West Lakeshore Drive to its intersection with the centerline of West Lake Estates Circle; thence, northerly along the centerline of West Lake Estates Circle to its intersection with the centerline of Iroquois Drive; thence, northerly along the centerline of Iroquois Drive to its intersection with the centerline of Arkansas State Hwy. 175; thence, northeasterly along the centerline of Arkansas State Hwy. 175 to its intersection with the centerline of Santee Drive; thence, northerly along the centerline of Santee Drive to its intersection with the centerline of Cherokee Road; thence, northerly along the centerline of Cherokee Road, swinging westerly over the South Fork of The Spring River to a point midway between Flathead Drive and Nebo Drive; thence, due north to the northern boundary of the incorporated city limits of the City of Cherokee Village.
