**BE** IT ORDAINED by the Cherokee Village City Council that the Cherokee Village Ordinance creating a city Planning and Zoning Commission in accordance with the Arkansas State law within Cherokee Village, Fulton and Sharp counties, Arkansas adopted by Ordinance 98-2 on December 21, 1998, be amended as follows:

**SECTION 1: CREATION** 

### Appointment and Terms of Members

The commission shall be comprised of seven members, all appointed by the mayor with the
advice and consent of the city council. All members shall be appointed at large. All members shall be
residents of Cherokee Village. Members shall receive no compensation for planning and zoning
commission service. Terms of members shall-be three (3) years, provided that members of the first

	Two (2) members shall have one (1) year term
•	Three (3) members shall have two (2) year term,
	Two (2) members shall have three (3) year term;

Any member may be reappointed to a three year term. Any position vacated <u>by a member shall</u> <u>be filled by the same procedure and for the period remaining in the term of that member.</u>

#### Secretarial Services

A secretary shall be appointed from by the commission for the purpose of taking notes and other measures at all meetings of the commission and composing and typing them in order to construct an accurate record of proceedings and actions. The appointment shall be for a term of one year.

SECTION 2. If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.
