

**AN ORDINANCE TO ESTABLISH WARD BOUNDARIES WITHIN THE CITY OF CHEROKEE VILLAGE LOCATED IN SHARP AND FULTON COUNTY, ARKANSAS**

**WHEREAS**, The City Council of Cherokee Village and its Subcommittee have made a comprehensive study and review of numerous records, documents and maps including, but not limited to the Federal Census report of those portions of Fulton County and Sharp County, Arkansas, known as Cherokee Village.

WHEREAS, it is the, opinion of the City Council of Cherokee Village that the Ward Boundaries as hereafter set **oulqualize, as accuratet** possible, the populations in various wards.

NOW BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHEROKEE VILLAGE, ARKANSAS AS FOLLOWS:

**1. Map of City** - The boundaries and limits of the wards within the City of Cherokee Village shall be as set forth and described on the official map, of the city, on file, in the office of the City Recorder/Treasurer.

**2. Ward Boundaries** - The following wards and their descriptions are hereby established: (Ward Boundaries Hereto Attached as Exhibit "1")

3. **Emergency Provisions** - Due to the urgency in completing, laying out, and determining the Wards of the City of Cherokee Village pursuant to Arkansas Code Annotated 14-40-203; 14-44-101 et.seq.; and due to the urgency in informing residents of Cherokee Village as to their particular ward; an emergency is hereby

declared to exist relative to the assignment of territories within Cherokee Village to certain Wards. Therefore, an emergency is declared and this Ordinance will be in full force and effect from and after its passage and approval of the majority and alderman of the City Council of Cherokee Village.
