#### **BILL OF ASSURANCE**

#### **TULARENOS ADDITION**

#### KNOW ALL MEN BY THESE PRESENTS:

That John A. Cooper Company, a corporation, and holds the title to all of the following described lands situated in Fulton County, Arkansas, to wit:

A parcel of land located in the SE  $\frac{1}{4}$  SE  $\frac{1}{4}$  (AC.29.357+) and the SW  $\frac{1}{4}$  SE  $\frac{1}{4}$  (AC.28.327+) both in Section 21, T-19-N, R-6-W along with a parcel of land located in the NE  $\frac{1}{4}$  NE  $\frac{1}{4}$  (AC.20.001+) and the NW  $\frac{1}{4}$ , NE  $\frac{1}{4}$ , both in Section 28, T-19-N, R-6-W, all in Fulton County, Arkansas, and more particularly described as follows:

Commencing at the Southeast corner of Section 21, T-19-N, R-6-W (Arkansas State Plane Coordinates 709.194.094 North and 112,168.930 East), run north 233.906 feet to a point; thence East 9.070 feet to the point of beginning; thence S 2°54'28" W, 664.919 feet to a point; thence, S 45°14' 53" E, 60.000 feet to a point; thence S 44°45' 07" W, 133.343 feet to a point; thence, S 36°16' 49" W, 116.606 feet to a point; thence, S 30°14'10" W, 175.556 feet to a point; thence N 64°19' 02" W, 181.530 feet to a point; thence N 76°39' 54" W, 138.741 feet to a point; thence N 82°29' 16" W, 183.576 feet to a point; thence N 88°06' 57" W, 152.082 feet to a point; thence N 74°28' 33" W, 168.134 feet to a point; thence N 58°47' 38" W, 243.187 feet to a point; thence N 66°04' 03" W, 194.743 feet to a point; thence N 74°59' 15" W, 227.774 feet to a point; thence N 83°44' 27" W, 155.929 feet to a point; thence N 72°50' 17" W, 284.675 feet to a point; thence N 51°58' 22" W, 99.020 feet to a point; thence S 72°50' 58" W, 155.574 feet to a point; thence N 30°18' 40" W, 73.991 feet to a point; thence N 14°26' 38" W, 136.308 feet to a point; thence N 9°35' 16" W, 150.097 feet to a point; thence N 24°44' 37" W,126.625 feet to a point; thence N 27°28' 28" W. 112.712 feet to a point: thence N 40°47' 29" W. 78.519 feet to a point: thence Northeasterly along the arc of a curve to the left, 437.606 feet to a point, radius of said curve being 478.222 feet and chord of said curve being 422.497 feet bearing N 35°32' 29" E; thence N 9°19' 36" E, 392.683 feet to a point; thence northeasterly along the arc of a curve to the left for a distance of 190.000 feet, radius of said curve being 618.254 feet and chord of said curve being 189.253 feet bearing N 0°31' 21" E; thence S 79°29' 36" E, 328.853 feet to a point; thence S 85°48' 54" E, 328.877 feet to a point; thence S 43°17' 55" E, 71.499 feet to a point; thence N 74°09' 18" E, 391.890 feet to a point; thence N 79°08' 37" E, 297.321 feet to a point; thence S 39°42' 11" E, 214.462 feet to a point; thence S 25°58' 46" E, 262.528 feet to a point; thence S 35°59' 29" E, 234.828 feet to a point; thence S 85°43' 43" E, 241.671 feet to a point; thence S 78°09' 29" E, 63.348 feet to a point; thence S 48°06' 22" E, 91.351 feet to a point; thence S 27°32' 10" E, 131.947 feet to a point; thence S 12°31' 44" E, 138.293 feet to a point; thence S 6°30' 32" E, 149.967 feet to a point of beginning and containing 85.840 acres more or less.

The Grantors, John A. Cooper Company, has caused said lands to be surveyed and subdivided into lots, blocks, and streets. Said subdivision has been named and shall henceforth be known and designated as Tularenos Addition, Cherokee Village Subdivision.

The Cherokee Village Tularenos Addition contains 8 blocks numbered 1 thru 8, and the Grantors have executed a plat showing the locations of said blocks and the number and dimensions of the lots in said blocks; also the locations, widths, and the names of the streets. All streets of said subdivision are hereby dedicated to the public for its use and benefit forever.

The plat of Cherokee Village Subdivision, Tularenos Addition is recorded in Plat Book 3 at Page 1 in the office of he Circuit Court Clerk and Ex-Officio Recorder in and for Fulton County, Arkansas.

As a part of this Bill of Assurance, certain safeguards and restrictions hereinafter referred to as "subdivision Restrictions" are hereby placed on the lots of said plat.

#### SUBDIVISION RESTRICTIONS

The purpose of these restrictions is to provide uniform protection for all property owners In these subdivisions by the establishment of a minimum standard of land use, building sizes, set-back requirements and the prohibition of certain undesirable uses and practices for the entire subdivision.

It is the intention of these restrictions to establish as a minimum of building requirements for all buildings erected on or moved onto any lot in this subdivision, all requirements for all building outlined by the Federal Housing Administration in the "Minimum Property Standards for Single Living Units," latest edition. This will be used as a guide for it, and in no way prevents the Architectural Control Committee from being more restrictive than the Federal Housing Administration minimums in this respect. Any restriction or requirement submitted by the Architectural Control Committee shall apply, should there be a conflict.

# I. <u>LAND USE</u>

All lots shown on said plats hereby are designated as a single-family residential district.

## II. GENERAL PROVISIONS

- (a) Nothing shall be allowable on premises in any zone established which would in any way be offensive or obnoxious by reason of color, design, or the emission of odors, liquids, gases, dust, smoke, vibration or noise. Nor shall anything be placed, constructed or maintained that would in any way constitute an eyesore or nuisance to adjacent property owners.
- (b) No building shall be erected, placed or altered on any lot until the construction plans and specifications and a plan showing the location of the structure have been approved by the Architectural Control Committee as to the quality of workmanship and materials, harmony of external design with existing structures, and as to location with respect to property topography and finish grade elevation. No fence or wall shall to erected, placed or altered on any lot nearer to any street than the minimum setback line unless similarly approved. It will be necessary for the contractor, builder, or individual constructing the said residence to notify us that a suitable completion bond has been made to insure completion of the home against material and mechanical liens. If the owner is doing his own building, it will be necessary for him to supply the necessary credit information and proof of financial ability to complete the structure within the time requirements hereinafter set forth. Proof of builder's risk insurance must be submitted.

The Architectural Control Committee is composed of John A Cooper, Joe N. Basore and George M. Billingsley. A majority of the committee may designate a representative to set for it. In the event of death or resignation of any member of the committee, the remaining members

shall have full authority to designate a successor. Neither the members of the committee nor its designated representative shall be entitled to any compensation for services performed pursuant to this covenant. At any time, the then record owners of a majority of the lots shall have the power through a duly recorded instrument to change the membership of the committee or to withdraw from the committee or restore to it any of its powers and duties.

The committee's approval or disapproval as required in these covenants shall be in writing. In the event the committee, or its designated representative fails to approve or disapprove within thirty (30) days after plans and specifications have been authorized to it or in any event if no suit to enjoin the construction has been made prior to the completion thereof, approval will not be required and the related covenants shall be deemed to have been fully complied with.

- (c) No building shall be erected or moved on to any lot of this subdivision which does not conform to the following restrictions of use, area, setbacks and other restrictions herein set forth.
- (d) No structures of a temporary character, trailer, basement, tent, shack, garage, barn or other out-building shall be constructed or placed on any lot without approval and at the time be used for a residential purpose.

The exterior of any building erected on or moved on to any lot in this subdivision shall be completely finished within six months of the date of the start of construction. This shall include underpinning, exterior siding, windows and doors, corner boards, molding chimneys, roof rakes, roof overhangs, roof cornices, fascias, porches, steps and any and all kinds of details of exterior construction or finish which in their absence shall change the appearance of the building from that approved by the Architectural Control Committee.

The interior of any building erected on or moved onto any lot in this subdivision shall be finished within twelve months following the start of construction. The electric wiring shall be at least in accordance with the Federal Housing Administration requirements. Plumbing shall be in complete accordance with the requirements set up by the Arkansas State Health Department or the Federal Housing Administration, whichever is more restrictive. Interior walls and ceilings of a standard nature such as sheet rock, plaster, paneling, finished floors, ceiling tile, etc., shall be complete and shall be in accordance with the Federal Housing Administration requirements. (This does not include paint, wallpaper, or the final finishing touches, but does include shades and/or curtains or drapes at the windows.)

The contractor-builder or owner will submit the house to a minimum of four inspections by the Architectural Control Committee and/or its representatives. In the event of non-compliance with this paragraph, the Architectural Control Committee shall have the right, but not the obligation, to hire a contractor to do the work necessary for compliance, and to bill the owner for this work together with a charge for administration amounting to 10 per cent of the contractor's bill. In the event that the owner does not pay said charges, the Architectural Control Committee shall have the right to file a lien against the property and proceed in law or equity to sell the property to obtain said charges. All money received over and above said charges and court costs to be returned to the owner.

(e) No lots as shown on said plats shall be re-subdivided into building plots, but a portion of a lot adjoining a lot may be used in connection with a lot and the total considered as a single building plot. The building line and side setbacks shall be determined with reference to such increased plot.

(f) All residences constructed on the property herein shall be for residential purposes only and the use of said residences, boat docks, and/or any portion of any lot for the practice of any profession or commercial business of any kind is prohibited.

No bee hives or the breeding or raising of any insects, reptiles, or animals and fowls other than customary house pets are permitted.

(g) No building shall be maintained or erected except that the owners shall install sewage disposal facilities which meet all requirements of the Arkansas State Health Department.

## III. SETBACK LIMITATIONS

Setback requirements shall apply to all structures constructed and erected on said property, as follows:

Front yard	25 feet from property line
•	5 feet from property line
Rear yard	25 feet from property line
Corner Lots	25 feet from front and 15 feet from side

Roof overhangs, steps, stoops and architectural projections are excepted.

## IV. HEIGHT LIMITATIONS

No building shall be greater than two stories in height nor higher from the average grade than 25 feet to any portion of the building except chimneys and architectural projections.

Garden walls, not exceeding 5 feet in height, may be constructed anywhere within property lines except in the area outlined in Section 8 and in no event will it be any closer to the lot lines than the minimum building setback unless specifically approved.

## V. AREA LIMITATIONS

No building shall be constructed in this addition unless it contains a minimum of 1000 square feet.

## VI. EASEMENTS FOR PUBLIC UTILITIES

Perpetual easements as shown on the plats for the use of utilities shall be maintained and become a restriction on each individual lot where they occur. Where utilities and easements occur on the rear of lots, the house sewer shall be located on the side facing the easement. In addition, each lot shall be subject to 5-foot easements for the installation of water mains and electric facilities. These facilities will be placed where most practical and least detrimental to the said lot. John A. Cooper Company, or its assigns reserves the right to declare such easements and install utilities without notification to lot owners.

# VII. GARBAGE AND REFUSE DISPOSAL

No lot shall be used or maintained as a dumping ground for rubbish. Trash, garbage, or other waste incidental to the use of the property as herein provided, shall be kept in sanitary containers.

## VIII. SIGHT DISTANCE AT INTERSECTIONS

No fence, wall, hedge or shrub planting which obstructs sight lines at elevations between 2 and 6 feet above the roadways shall be placed or permitted to remain on any corner lot within the triangular area formed by the street property lines and a line connecting them at points 25 feet from the intersection of the street property line with the edge of a driveway or alley. No trees shall be permitted to remain within such distance of such intersections unless the foliage line is maintained at sufficient height to prevent obstruction from sightline.

## IX. SIGNS

No signs of any kind or for any use or purpose whatsoever shall be erected, posted, pasted, painted, or displayed upon any of said lots or upon any building or any other structure thereon without the prior written permission of the Architectural Control Committee.

# X. TERM

These covenants are to run with the land and shall be binding on all parties and all persons claiming under them for a period of twenty-five (25) years from the date these covenants are recorded, after which time said covenants shall be automatically extended for successive periods of ten (10) years unless an instrument signed by a majority of the then owners of the lots has been recorded, agreeing to change said covenants in whole or in part.

## XI. <u>SEVERABILITY</u>

Invalidation of any of those covenants by judgment or court order shall in no wise affect any of the other provisions which shall remain in full force.
