

Ordinance NO. 2008-02

AN ORDINANCE ESTABLISHING PERMIT COSTS AND PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES.

BE IT ORDAINED BY THE CHEROKEE VILLAGE CITY COUNCIL THAT:

THE LANGUAGE OF ORDINANCE 2003-5 IS HEREBY STRICKEN AND REPLACED BY:

SECTION 1: WHEREAS, it is the desire of the Cherokee Village City Council to establish the following permit charges in Exhibit A, COSTS SCHEDULE:

SECTION 2: SCHEDULE OF COSTS

(a) The schedule of costs shall be posted in the office of Planning & Zoning and may be altered, changed or amended by the Planning & Zoning Commission and presented to the City Council for approval.

(b) There will be a thirty dollar (\$30) charge for each additional inspection over the required number of inspections for a given job. These inspection charges will be subtracted from the four hundred dollars (\$400) REFUND as well as any other miscellaneous charges.

(c) No permit shall be issued unless or until such costs, charges, or expenses have been paid in full, nor shall any action or construction proceed before the approval of the Planning and Zoning Commission and until such costs and charges have been paid in full.

SECTION 3: PENALTIES. Violation of the provisions of this ordinance or failure to comply with any of its requirements shall constitute a misdemeanor. After the expiration date indicated by the notice of violation, any person, firm or corporation who violates this ordinance or fails to comply with any of its requirements shall, upon conviction thereof, be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than thirty (30) days, or both, and in addition shall pay all costs and expenses involved in this case. After the expiration date indicated by the notice of violation, each day such violation continues shall be considered a separate offense.

SECTION 4: SEVERABILITY. If any part of this ordinance shall be held to be invalid, such part shall be deemed severable and the invalidity thereof shall not affect the remaining parts of the ordinance.
