

CITY OF CHEROKEE VILLAGE, ARKANSAS

AN ORDINANCE RELATING TO THE AMENDMENT OF ZONING REGULATIONS FOR THE CITY OF CHEROKEE VILLAGE, ARKANSAS AND FOR OTHER PURPOSES

WHEREAS, the City of Cherokee Village, Arkansas, has adopted zoning regulations for the orderly development of the city and the protection of the citizens of the City, and WHEREAS, the Planning and Zoning Commission of the City of Cherokee Village, Arkansas, held a public meeting on March 7th, 2022 for the purpose of considering proposed amendments and modifications of the zoning regulations adopted by the City of Cherokee Village, Arkansas

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHEROKEE VILLAGE, ARKANSAS:

SECTION 1: Zoning Regulations. That the amended zoning regulations for the City of Cherokee Village, Arkansas, (*amending zoning of certain property in the City of Cherokee Village, Arkansas, currently light industrial to include agricultural with restrictions, to exclude, pigs, chickens, sheep, goats and/or their dwelling, plat map and legal description attached*) prepared by the City of Cherokee Village Planning and Zoning Commission and adopted by it on March 7th, 2022, after a public hearing was held on March 7th, 2022, are hereby adopted. Three copies of the zoning regulations as amended are on file in the office of the City Clerk and are available for public inspection.

SECTION 2: Penalties. Any person, firm or corporation found guilty of violating any of the provisions of this Ordinance shall be fined for each such violation as provided by law.

SECTION 3: If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

EMERGENCY CLAUSE. It being necessary for the continued orderly planning of the City of Cherokee Village, such planning being necessary for the preservation of the health, welfare and safety of the citizens of the City, the City Council of the City of Cherokee Village, Arkansas, recognizes and declares an emergency to exist, and this Ordinance, being necessary for the preservation of the public peace, health, comfort, convenience, morals, safety and welfare of the City of Cherokee Village, Arkansas, shall be in full force and effect from the date of its adoption.

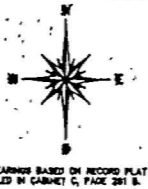

M.), Sharp County, Arkansas, AND part of the Southeast Quarter of the Southeast Quarter(SE/4-SE/4), 3.56+/- acres of Section 25, and part of the East Half of the Northeast Quarter(E/2-NE/4), 39.74+/- acres of Section 36, Township 19 North, Range 06 West(T19N-R06W) of the Fifth Principal Meridian (5th P. M.), Fulton County, Arkansas.

Highway 62/412, thence along said right of way South 74 degrees 05 minutes 09 seconds West 98.86 feet, thence leaving said right of way North 51 degrees 53 minutes 24 seconds West 203.46 feet, thence North 53 degrees 19 minutes West 42.58 feet, thence South 64 degrees 42 minutes 11 seconds West 378.60 feet, thence North 88 degrees 28 minutes 21 seconds West 318.86 feet, thence North 00 degrees 56 minutes 35 seconds West 1327.81 feet, thence North 01 degree 19 minutes 05 seconds West 188.86 feet to the southeasterly boundary of Santa Fe Addition Cherokee Village, thence along said boundary North 36 degrees 41 minutes East 3923.60 feet back to the Point of Beginning, containing in aggregate 83.41 acres, more or less.

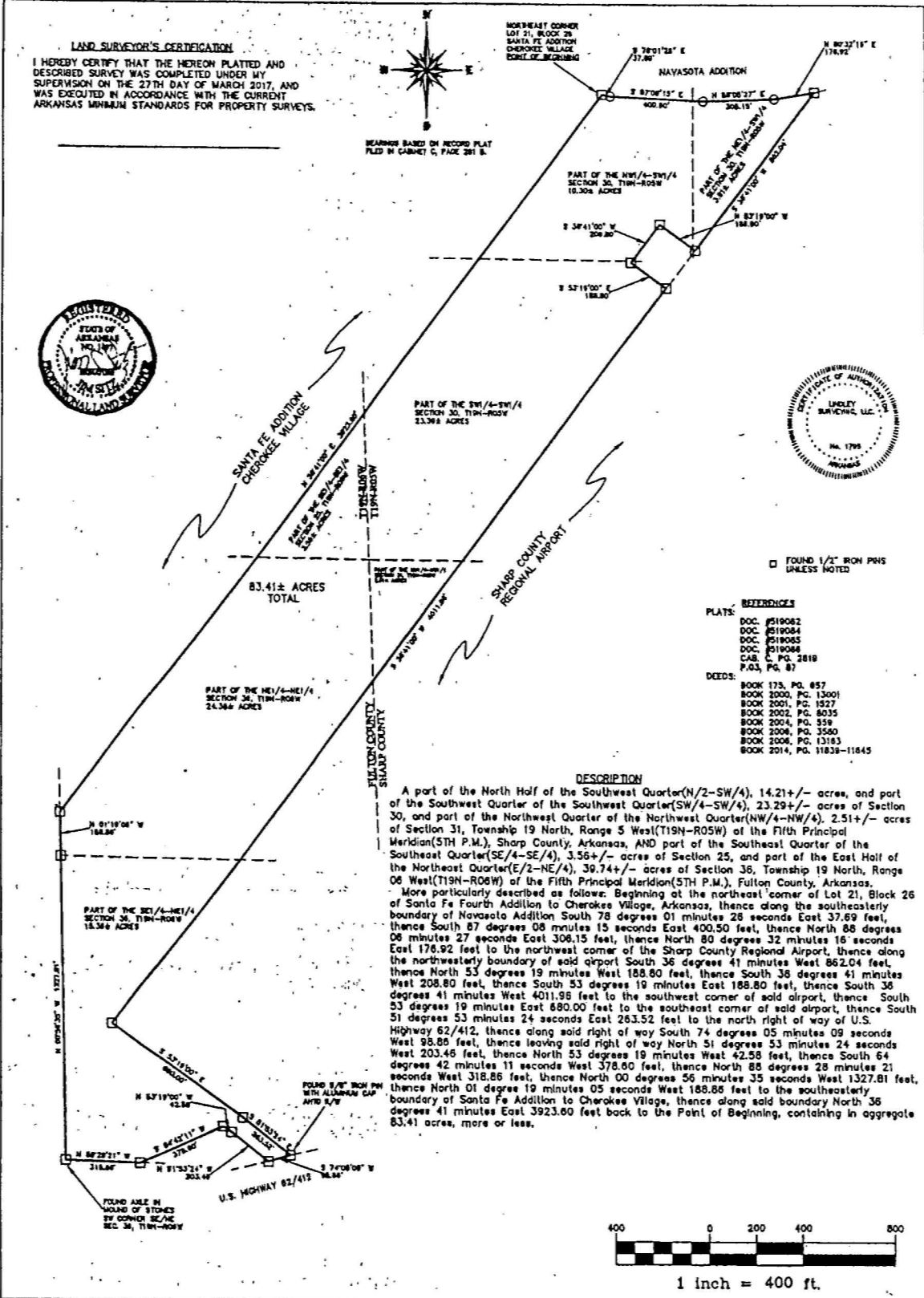

BEARINGS BASED ON RECORD PLAT FILED IN CABINET C, PAGE 281 B.



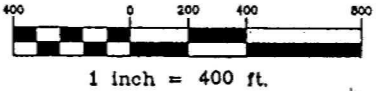
