WHEREAS, the City Council of the City of Cherokee Village, Arkansas, having met in session on the 17th day of May, 2018, to hear the testimony and evidence presented on the issue of the costs of removing the building on the property Lot 45, Block 3, Sequoyah Addition to Cherokee Village Subdivision, Sharp County, Arkansas, owned by Ms. Cherisa Leggett, 770 East Jackson, Piggott, AR 72454, under a Resolution to Raze and Remove approved by the City Council of Cherokee Village, Arkansas, and

WHEREAS, the owner of the property has been duly notified of the hearing and had an opportunity to be heard and offer evidence on his or her behalf.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Cherokee Village, Arkansas, with the approval of the Mayor, that the City of Cherokee Village, Arkansas, is authorized to certify to the County Tax Collector of Sharp County, Arkansas, for collection as delinquent taxes the amount of \$5,378.53 (five thousand three

hundred seventy-eight dollars and fifty-three cents), representing the costs incurred by the City of \$4,889.58 (four thousand eight hundred eighty-nine dollars and fifty-eight cents) plus ten percent penalty of \$488.95 (four hundred eighty-eight dollars and ninety-five cents) for collection.






